### Required Documents

The following documents must be completed and verified for each nominee:

- A high-resolution portrait photo in .png or .jpg format
- Completed application form
- A short write up in paragraph form (not more than 350 words) summarizing the accomplishments and contributions of the nominee.
- Curriculum vitae
- Supporting documentation including publications, citations and any other notable achievements of the nominee within the scope of this Award.

### **Deadline of Nominations**

All nominations will only be accepted until March 13, 2020. Evaluation of all nominations will be held on March 19, 2020 and approved at the 3<sup>rd</sup> Meeting of the 15th FAPA Bureau on March 20, 2020. The winner shall be announced and communicated to all member organizations.

### **Prize**

All awardees shall receive a certificate of recognition, a gold-plated medal and cash award to be presented in the opening ceremonies of the FAPA Congress.
